1. Revision to the forecasts for fiscal year ending March 31, 2024 (From April 1, 2023 to March 31, 2024)

2. Reasons for revision

The consolidated earnings forecasts for the fiscal year ending March 31, 2024 are now expected to be lower than the previously announced figure, although sales of "COSMOSHINE SRF" expanded, due to the impact on profits from a slow recovery in demand for packaging film and mold releasing film for MLCC, as well as raw material and fuel prices remaining high.

(Note) The above business forecasts have been prepared based on the information available as of the date of this announcement, and actual results may differ from these forecasts due to various factors.
